The WeRPN membership year is July 1st to June 30th, and the Payroll Deduction Program is made in the preceding year, so the full amount is provided to WeRPN before the new membership year begins again on July 1st.

For example, your RPN employees would incur monthly deductions from July 2020 to May 2021, and the total membership of \$296.15 payment must be received by WeRPN by June 1st, 2021, to ensure their membership benefits including Professional Liability and Malpractice Insurance remains uninterrupted.

WeRPN Membership Fee: July 2021-June 2022 \$262.08 + \$34.07 HST = \$296.15
